## **Investment Objective**


The primary objective of the Northern Trust Collective Russell 1000 Value Index Fund - DC - Non-Lending is to approximate the risk and return characteristics of the Russell 1000 Value Index. This Index is commonly used to represent the large cap segment of the U.S.market with a focus on the "value" style of investing.

## **Investment Approach**

To achieve its objective, the Fund employs a replication technique which generally seeks to hold each index constituent in its proportional index weight. The Fund may make limited use of futures and/or options for the purpose of maintaining equity exposure. This Fund may not participate in securities lending.
