**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ The Northern Institutional Funds-International Equity Portfolio merged into Northern Funds International Equity Fund through the acquisition by Northern Funds International Equity Fund of all the assets of The Northern Institutional Funds-International Equity Portfolio in exchange for voting shares of beneficial interest ("shares") of Class A shares of The Northern Institutional Funds-International Equity Portfolio and the assumption by Northern Funds International Equity Fund of all liabilities of The Northern Institutional Funds-International Equity Portfolio followed by the distribution by The Northern Institutional Funds-International Equity Portfolio of those shares pro rata to its shareholders in complete liquidation of The Northern Institutional Funds-International Equity Portfolio. The merger of The Northern Institutional Funds-International Equity Portfolio into Northern Funds International Equity Fund qualifies as a tax free exchange within the meaning of Internal Revenue Code Section 368(a).

The exchange is based on the number and value of shares outstanding at the close of business on November 9, 2012.

**15** Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ A shareholder's aggregate basis in the share of Northern Funds International Equity Fund he/she received in exchange for his/her shares of The Northern Institutional Funds-International Equity Portfolio will be the same as his/her aggregate basis in shares of The Northern Institutional Funds-International Equity Portfolio. The number of Northern Funds International Equity Fund shares that were received for each share in The Northern Institutional Funds-International Equity Portfolio given up in the exchange is as follows:

The per share basis calculations are based on the respective NAV's of the target fund and the acquiring fund at the close of business on the date of the merger. NAV's are valued primarily based on the FMV of the underlying assets.
