# **Investment Objective**

The primary objective of the Northern Trust Collective Aggregate Bond Index Fund - Non-Lending is to hold a portfolio representative of the overall United States bond and debt market, as characterized by the Bloomberg U.S. Aggregate Bond Index.

#### **Investment Approach**

The fund invests ininvestment-grade securities covering the Treasury, Agency, Mortgage-backed, Asset-backed, Commercial mortgage-backed, and Credit sectors of the U.S. Bond Market. The Fund may make limited use of interest rate futures and/or options for the purpose of maintaining market exposure, and may not participate in securities lending.
