

# NORTHERN FUNDS EQUITY AND FIXED INCOME FUNDS

## 2025 CAPITAL GAIN DISTRIBUTIONS

At least once a year, mutual funds must distribute to shareholders any capital gains realized from selling securities within the funds. In 2025 Northern Funds paid capital gain distributions on **December 18th** to shareholders of record as of **December 17th**, except for the Global Tactical Asset Allocation Fund which paid 2025 capital gains on **December 30, 2025** for shareholders of record as of **December 29, 2025**.

The tables below list per share distribution amounts for the Northern Funds. These amounts will also be reported on year-end statements and the taxability of these distributions will be reported on your form 1099-Div which will be mailed to you in January 2026.
